

## **User's Consent personal data processing**

In accordance with Articles 23, 24 of the Constitution of the Russian Federation, the Federal Law No. 152-FZ «On Personal Data» dated 27.07.2006, the Policy for Processing Personal Data of visitors to the website <https://asiamc.ru/> visitors, posted on the website of Limited Liability Company "AziyaMedKonsalt" at [https://asiamc.ru/uploads/docs/personal\\_data\\_policy\\_202502\\_en.pdf](https://asiamc.ru/uploads/docs/personal_data_policy_202502_en.pdf) (hereinafter - the Policy for Processing Personal Data),

I, the subject of personal data (hereinafter - the User), by entering the data belonging to me in the special fields, placing the symbol of consent (tick) in the special field (checkbox) and then clicking the button "Send", as the subject of personal data freely, of my own free will and in my own interest in accordance with the requirements of the Russian Federation's Federal Law No. 152-FZ "On Personal Data" dated 27.07.2006 express my full, unconditional and unambiguous consent to the processing of my personal data (hereinafter - Consent) for the use of the website <https://asiamc.ru/> visitors and its services (hereinafter - the Site, Service), and further when using the Site and/or its Services, on the following conditions:

**1. Consent has been given to AziyaMedKonsalt Limited Liability Company (AMK LLC, INN 7709929540, OGRN 1137746433879),** located at the address: 109004, Moscow, 27, Alexander Solzhenitsyn St., floor 1, premise III, room 10 (hereinafter referred to as the Operator).

**2. Consent is granted for the processing of personal and other data** entered by the User in the special fields by filling in the relevant special fields and/or attached files, namely the following categories:

- surname, first name, e-mail address;
- other data that the website user may, on his/her own initiative, send to the Operator in freely fillable fields of feedback forms or in files attached to them.
- cookies;
- visitor data collected by the Internet statistics service Yandex Metrika;
- user data (location information; OS type and version; browser type and version; device type and screen resolution; source from where the user came to the site; from which site or advertising; OS and browser language; which pages the user opens and which buttons the user clicks on; ip address);

**3. Consent has been given for the processing of personal data for the purposes of:**

- provision of services, processing of requests and applications;
- collection of statistics on the Site by the Operator;
- improving the quality of the Site and/or its Service, their usability and the development of new services and facilities;
- organising the functioning and technical support of the Website and/or its Service.

In accordance with the above-mentioned purposes, the Operator processes the following personal data of the personal data subject:

3.2.1 To fulfil agreements on providing access to the Website, its Content and/or Service, to the functionality of the Service, to administer the Website, to collect statistics on the Website by the Operator, to improve the quality of the Website and/or its Service, their usability and to develop new services and services, to **organise** the functioning and technical support of the Website and/or its Service:

- Cookies (cookies);
- User data (location information; OS type and version; browser type and version; device type and screen resolution; source from where the user came to the site; from which site or advertising; OS and browser language; which pages the user opens and which buttons the user clicks on; ip address);
- Data on visitors collected using the Internet statistics service Yandex Metrika;
- Other data that the website user may at his/her own initiative send to the Operator in freely fillable fields of feedback forms or in files attached to them.

3.2.2 In order to provide services, process requests and applications:

- The email address of the site visitor;
- Surname, first name, patronymic of the site visitor;
- Other data that the website user may on his/her own initiative send to the Operator in freely fillable fields of feedback forms or in files attached to them.

The User hereby confirms, is aware and agrees that for the above purposes, the Operator has the right to collect and use additional information related to the User, obtained in the process of the User's access to the Site, its Content and/or Service, or from third parties, and including data on technical means (including mobile devices) and methods of technological interaction with the Site and/or its Service (including host IP address, type of the User's operating system, browser type, geographical location, data on the User's access to the Site, its Content and/or Service, etc.).

**4. Consent is given for processing personal data in a mixed (automated and non-automated) manner.**

**In the process of personal data processing, the Operator has the right to** collect, record, systematise, accumulate, store, clarify (update, change), extract, use, transfer (distribute, provide, access), depersonalise, block, delete, destroy the User's personal data.

**5. The User hereby confirms that he/she:**

**5.1 Gives consent to the Operator to process his/her personal data** specified in clause 2 of this consent, as well as confirms the Operator's explanation of the consequences of failure to provide personal data, in cases where the provision of such data is mandatory in accordance with federal law.

**5.2 Informed of the possibility to withdraw the consent** on the basis of the provisions of the Federal Law No. 152-FZ «On Personal Data» dated 27.07.2006 by personal application or by sending a written application (including in form of an electronic document signed with a simple electronic signature or an enhanced qualified electronic signature) to the persons specified in paragraph 1 of the Consent, including informed of the right to withdraw the Consent in order to stop processing by the person specified in paragraph 1 of the Consent, as well as all the persons specified in paragraph 1 of the Consent.

**5.3 I am informed that the persons specified in paragraph 1 of this Consent have the right to continue processing of the User's personal data** after receiving the revocation of the Consent, as well as after the expiry of the Consent, if there are grounds provided for in Article 9, paragraph 2 of the Federal Law dated 27.07.2006 No. 152-FZ "On Personal Data".

**6. The consent comes into force from the moment of its sending and may be withdrawn** by the User by sending a written application in any form to the Operator to the e-mail address [info@asiamc.ru](mailto:info@asiamc.ru) or in any other way that allows to unambiguously determine the fact of its receipt by the addressee.

**7. The Consent is valid for an indefinite period of time until revoked by the User.** The Consent shall terminate from the date specified in the User's application for revocation of the Consent to process Personal Data, but not earlier than the date following the date of actual receipt of the revocation of the Consent by the Operator.

**8. The date and time of formation, confirmation and sending of the Consent** shall be deemed to be the moment of marking the relevant field (or clicking on the relevant button) in the Form and/or clicking on the button for sending the Form on any page of the Site and/or its Service.

**9. Guided by part. 4 of Article 9 of the Federal Law dated 27.07.2006 No. 152-FZ "On Personal Data", I send my personal data via my personal mobile device or personal computer by attaching it to a special form or by filling in the relevant fields of such form when registering on the Website.**

**10. The User is informed that the responsibility before him/her for the actions of the person processing his/her personal data on behalf of the Operator is borne by the Operator who issued the relevant instruction (consent).**
